

Preble Street Votes: Election Guide

Election Day is Tuesday, November 8!

Polls are open from 7am – 8pm

If you aren't registered to vote yet and would like to, you can register AND vote on Election Day! Early in-person voting at the Town Clerk's office is also available in Maine through Thursday, November 3.

WHO can vote in Maine?

- **Maine has some of the most progressive voting laws in the country**
- **You can vote even if you have a felony**
- **You don't need a home to vote! In Maine, there is no requirement for a fixed address, though you must provide some form of proof of "residency."** If you aren't already registered and plan to do so on Election Day/if you work with Preble Street, we recommend listing one of our locations on your voter registration as your address. If you have a non-traditional address, you can offer a physical description of your place of residence (e.g a campsite, a park bench) to the clerk, this will replace a physical address.

Did you know...Maine is one of sixteen states in the U.S. that does *not* require ID to vote. *However, it is required in order to *register* to vote*

Nonetheless, it is best to bring a form of ID with you on Election Day.

- Especially if it's your first time voting in Maine and you did not provide the state with a copy of your ID when registering to vote, it's best to **bring a form of ID!**

In certain races on your ballot, you will have the **option** to participate in **ranked-choice voting**:

- Ranked-choice voting allows voters to choose candidates in order of preference
- Votes are tabulated in rounds until only two candidates remain and one candidate is determined to have received the majority of votes in the final round. That candidate is then declared the winner.





ARE YOU VOTING IN PORTLAND?

If so, there are a total of 13 extra questions on the ballot pertaining to local issues from the Charter Commission and Referendum! Take the time to read up on these questions before you get to the polls.

The referendum questions are as follows:

Referendum Questions:

This language is directly as the information was presented to the Portland City Council

QUESTION A: An Act to Regulate Short-Term Rentals and Prohibit Corporate and Absentee Operation of Short-Term Rental Properties

- Prohibits corporate owners and non-local operators from registering short-term rentals in the city.
- Prohibits eviction of tenants for the purpose of immediate conversion to the short-term rentals.
- Prohibits affordable and workforce housing from being used as short-term rentals.
- Increases penalties for disorderly properties and violations of the city's existing short-term rental regulations.

QUESTION B: An Act to Reduce the Number of Short-Term Rentals in Portland

- Restricts all Portland STRs to those that are owner-occupied, tenant-occupied, or located in a two-unit building occupied by the owner.
- Increases annual fee for owner-occupied STRs to \$250 and non-owner occupied STRs to \$750 and simplifies fee structure.
- Requires notification to all residents within 500 feet of a registered STR.
- Increases penalties for violations and strengthens enforcement of violations.
- Requires logging of complaints against all STRs.
- Allows the city to revoke STR registrations.

QUESTION C: An Act to Protect Tenants in Portland

- Ensures that tenants receive 90-day notice for lease termination and/or rent increases.
- Discourages no-cause evictions by limiting the 5% rent increase to voluntary turnovers.
- Restricts deposits to one month rents, prohibits application fees, limits amount of standard annual rent increases to 70% of CPI.

- Strengthens protections for tenants who exercise their rights under the existing ordinance.
- Provides greater clarity and authority to the rent board to ensure landlords receive a fair return on investment and tenant complaints receive a fair hearing.
- Sets a \$25,000 fee for condominium conversions.
- Technical changes to the original ordinance.

QUESTION D: An Act to Eliminate Sub-Minimum Wage, Increase the Minimum Wage, and Strengthen Protections for Workers

- Increases minimum wage in Portland to \$18 an hour over three years and will eliminate sub-minimum wage for tipped workers over the same three years.
- Tipped workers will receive \$18/hr plus tips.
- Provides an \$18 an hour minimum wage for workers not currently receiving the minimum wage (taxi-drivers and other ride services, personal shoppers, delivery workers, and those doing work for a unit of government).
 - Creates a Department of Fair Labor Practices.

QUESTION E: An Act to Reduce Cruise Ships in Order to Reduce Congestion and Pollution

- Limits the number of passengers who may disembark from cruise ships to no more than 1,000 people on a given day (in total).
- This ordinance will go into effect in 2025.

If you are voting in Portland, they will ask you about the recommendations of the Charter Commission. There are 8 questions pertaining to these recommendations on your ballot —

Question 1: Proposes an amendment to the preamble of the City Charter, with the inclusion of a Land Acknowledgement to honor Indigenous People in Portland and throughout the state.

Question 2: Strengthens the position of the mayor, positioning them as a chief executive of the city. City manager will be replaced by a city administrator position (with less power). This question also proposes expanded the City Council and School Board, to twelve and nine members, respectively.

Question 3: Establishes a publicly funded “Clean Elections” program in Portland, banning corporate contributions to candidates/campaigns.

Question 4: Allows the city to implement a ranked-choice voting method for certain elections where more than one candidate is being elected to a given seat. This would include races with multiple at-large seats up for election.

Question 5: Aims to reshape the school budget adoption process, so that it no longer requires city council approval. The budget would go directly to voters after school board approval.

Question 6: Establishes the Peaks Island Advisory Council as part of the city council, so that Peaks may have representation in municipal matters on the mainland.

Question 7: Establishes a Civilian Police Review Board, replacing the current police review subcommittee. This group would be able to review PPD's internal investigation reports and hear complaints directly from residents of Portland.

Question 8: Establishes an Ethics Committee for the City and a Code of Ethics. This also includes the funding to hire an Accountability Officer, who can consult with the city council as an unbiased third party in ethics-related matters.
